CONTRACT AGREEMENT

SUPPLY OF FUEL FOR ELEVEN (11) MONTHS AT SAN JORGE CAMPUS

This Agreement is entered into by and between the "NORTHWEST SAMAR STATE UNIVERSITY (NwSSU)", situated at Rueda Street, Calbayog City, herein represented by DR. BENJAMIN L. PECAYO, in his capacity as the University President, hereinafter referred to the "FIRST PARTY";

-and-

"CORRALES GASOLINE STATION", situated at Poblacion II, San Jorge, Samar, herein represented by MS. SUNSHINE D. KADIL, in her capacity as the Proprietor, hereinafter referred to as the "SECOND PARTY";

-WITHNESSETH-

THAT, after a fair canvass of the prices for fuel with PR No. 2024-02-064, the "FIRST PARTY" found it advantageous and convenient to have the supply of fuel be contracted with the "SECOND PARTY";

THAT, the "FIRST PARTY" shall take or acquire fuel on credit for the NwSSU-San Jorge Campus operation of its motor vehicles and other machines requiring the same at the "SECOND PARTY";

THAT, the "SECOND PARTY" shall allow the "FIRST PARTY" to acquire fuel on credit not exceeding to the total Approved Budget for the Contract of Eighty Thousand Pesos Only (PhP80,000.00) from STF for a period for Eleven (11) Months, or until such Contract Price is consumed, whichever comes first;

THAT, the "SECOND PARTY" shall issue a Delivery Receipt with corresponding quantity and amount per withdrawal of fuel at the prevailing market price;

THAT, withdrawal of fuel shall be through a Withdrawal Slip duly signed by the Supply Officer and Vice President for Administrative Affairs or their duly Authorized Representative; Jniversity President

THAT, the "SECOND PARTY" shall issue a Billing Statement every 5th of the succeeding month and submit to the Procurement Office;

THAT, the "FIRST PARTY" shall pay its monthly obligation of fuel to the "SECOND PARTY" immediately after reception of the latter's billing statement;

THAT, the "FIRST PARTY" shall only pay the "SECOND PARTY" those fuel withdrawn with duly accomplished Withdrawal Slip;

THAT, the "FIRST PARTY" shall bind itself to pay the cost of the fuel taken out from the "SECOND PARTY" at the prevailing market price as indicated in the Billing Statement and/or computed in accordance to "sales to government account" under the paragraph 3 of Quick Guide on E-VAT for Gasoline Dealers which form part and parcel of this "Contract";

THAT, the term of this "Contract" shall be for the period of Eleven (11) Months and will start from the approval of this Contract;

THAT, the University may terminate the Contract on its own prerogative with justifiable reason.

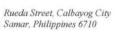
