



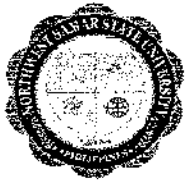

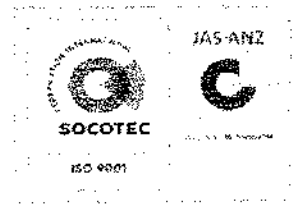

## CONTRACT OF AGREEMENT FOR PURIFIED DRINKING WATER

This AGREEMENT is entered into by and between the "NORTHWEST SAMAR STATE UNIVERSITY-MAIN CAMPUS" located at Rueda Street, Calbayog City, herein represented by DR. BENJAMIN L. PECAYO, in his capacity as the University President, hereinafter referred to as the "FIRST PARTY"

-and-

"NwSSU EMPLOYEES -MULTIPURPOSE COOPERATIVE", located at Rueda Street, Calbayog City represented by MR. CORNELIO C. BAUTISTA, JR. in his capacity as NwSSU-EMC Chairman, hereinafter referred to as the "SECOND PARTY" being the lowest responsive offered;

-WITNESSETH-

THAT, after a fair canvass of the prices for purified drinking water with PR No.2022-02-012 among refilling stations in the City of Calbayog, the FIRST PARTY found it advantageous and convenient to have the supply and delivery of purified/ mineral drinking water requirements for one (1) year contract not to exceed the ABC for the University-Main Campus to be contracted with the SECOND PARTY;

THAT, the SECOND PARTY agreed to supply and deliver to the FIRST PARTY the purified drinking water requirements for the University-Main Campus at Twenty Nine Pesos (Php29.00) per container (equivalent to 5 gallons per container), and every purchase of ten (10) containers the SECOND PARTY will give an additional one (1) for free (10+1), refill only, to be paid monthly by the FIRST PARTY;

THAT, the SECOND PARTY shall lend hot and cold water dispenser, including new/acceptable containers and outright replace the old/unacceptable containers to the FIRST PARTY;

THAT, the SECOND PARTY shall present a portable test result to the FIRST PARTY;

THAT, the FIRST PARTY shall pay the SECOND PARTY monthly basis (government procedure) in the amount stated in the billing statement provided by the latter;

THAT, either party may terminate at the midst of the contract with proper notifications and justifiable cause;

THAT, the term of this Agreement shall take effect a day after the parties signed this instrument and extendable/renewable at the option of the FIRST PARTY;


